### **BOD MEETING - January 17, 2015**

(Please note these are just highlights of the meeting and not the official "Minutes of the Meeting.")

Fisheries Committee: Report was given by Richard DeBow. He spoke on the DFO Dec 17 Consultation meeting. Lack of timely notification was a major issue; giving us insufficient time to consult with our membership. In response to James Foster's Times & Transcript article on the low salmon returns in the Miramichi River, our committee drafted a media response cautioning against a knee jerk response to these numbers and felt that the recommendation for a total hook and release fishery is not justified. The Committee drafted a proposed submission stating NBWF does not support listing Striped Bass under SARA and feels that current population numbers don't warrant it Lack of news on Stripped Bass in the Miramichi Lake was raised and the Committee is to query DFO on this subject.

Fisheries Liaison meeting with DNR had been postponed till after the Christmas holiday period and subjects such as Salmon barriers and issues of crown reserve waters will be dealt at this time.

Minister Shea had announced a Salmon Task Force to deal with low returns of the Atlantic salmon and excluded the NBWF from this process while including the ASF and MSA as the two appointed NB representatives on this Task Force. A letter was presented to the Board, approved, and later sent to Minister Shea pointing out that the ASF is a regional organization and the MSA is a local organization specific to the Miramichi and that the NBWF who has traditionally, and should continue, to represent NB on such committees.

**Zone VP:** Jason Soucy and Gilles Sonier presented reports. Jason stated his disappointed by lack of lakes in his area being added to the list of lakes eligible for ice fishing. He felt that the biologist had not submitted these lakes to DNR for consideration. Gilles said that the blueberry growers seem to be following regulations agreed upon for their farms (buffer zones, etc).

**AGM Committe**: Jim stated that plans are well underway. The application form was sent around. Decisions are yet to be made regarding who will be guest speakers for the meeting.

Fracking Committee: Rod Currie gave a preliminary report from the Fracking Committee but as there is still one issue to be dealt with and many wishing to comment, the committee agreed to have its final report ready before the end of February so that Affiliates may take it to their clubs before final discussion and voting at the AGM.

Resolutions: Acting Resolutions chair, Jim Marriner, reported that the 2014 resolutions would be sent by email shortly after the meeting.

<u>Wild Life Committee</u>: Kevin Sabean reported on potato farmers request to move moose season earlier by one week. It was voted that NBWF would not support this request. He also reported rumours that moose season could return to a 3 day season and, as we have a standing resolution for a longer moose season, he was to write to DNR opposing a return to the shorter season.

#### Other topics discussed at the meeting:

- -- A Forest Foundation of New Brunswick presentation was given by Tony Henderson regarding their organization and requesting the NBWF Affiliates to submit wildlife habitat improvement projects for funding; stating that The FFNB's aim was to aid Clubs with such projects. Therefore, they are having another lottery. Prizes include: Moose Hunt, Miramichi Salmon Trip, Tikka Rifle, Stryker crossbow bow, and a G Loomis Pro Fly Rod including a Plueger Trion reel, line, case.
- -- NBWF is looking at purchasing NBWF logo hats, T-shirts and/or crests. We are currently contacting suppliers for prices. Final decisions will be dealt with by the NBWF Executives. We will try to have some of these items avail at the AGM.
- -- As mentioned in Fisheries, a discussion was held regarding DFO consultations meetings. We received notice of major agenda topics only days before the meeting which made it impossible to consult with our Affiliates. Then, we were asked to respond in a little over two weeks across the Holiday season. Due to this, it was voted that the VP send a letter of protest to DFO stating that this is not proper consultation and that this practice must be corrected in the future as we must have adequate time to consult with our membership.
- -- Regarding the IBoF salmon stocking project by Fort Folly Band in Partnership with Fundy National Park, NBWF will be sending a letter protesting the fact that we were not consulted prior to the start of the project.
- -- Discussion was held with regards to the experiment being undertaken by Parks Canada and the Fort Folly Reserve. Ron Whitehead gave us a summary of their presentation at the Petitcodiac Sportsman's Club. This said basically that they have taken smolt from the Pollett River and placed them in Cooke Aquaculture open sea pens to raise to adults and then plan to return them to the river.

The NBWF will have to review this project to see if we support it or not.

However as we only learned through the press of this 2.6 million dollar project which as far as we know was started without the consultation of stakeholder groups, the VP has been directed to write a letter to Parks Canada and DFO protesting this and requesting any environmental impact studies.
